This letter is to confirm your acceptance of employment as a Lecturer in Law for us during the ~~2007 Spring Semester~~ 2007 Spring Semester. As indicated on the enclosed class schedule, your Election Law class will meet on Tuesday and Thursday evenings from 8:00-9:30 p.m. in room 1010 of the Law Center. The first day of classes will be on January 8, 2007, and the last day of law school classes will be Friday, April 20, with exams the following two weeks. The scheduled holidays for the spring semester will be Monday, January 15, Martin Luther King Day; Monday, March 5, through Saturday, March 10, Spring Break.

This appointment is contingent upon the availability of funding and enrollment. If the course is cancelled or reassigned, you will be informed no later than its second meeting. Your gross salary for this assignment will be \$3,000. Please be aware that the gross amount shown on your paycheck stub will be minus your tax sheltered 9.3 percent contribution to STRS. After your employment has been terminated, you may request this contribution be returned to you; however, the "matching" University contribution is non-refundable.

You may pick up your parking permit at the Campus Community Support Services Office, 1610 Rocket Hall, or order it on-line (<http://parkingservices.utoledo.edu/>) after January 2, 2007. At the same office, you can also obtain an ID card to use in Carlson Library.

This offer is a non-tenure track appointment and employment is only for the period stated and carries with it no explicit or implicit commitment to continued employment beyond that time. This is the only notice of termination of contract you will receive. Please return a signed copy of this letter of agreement to me as soon as possible.
